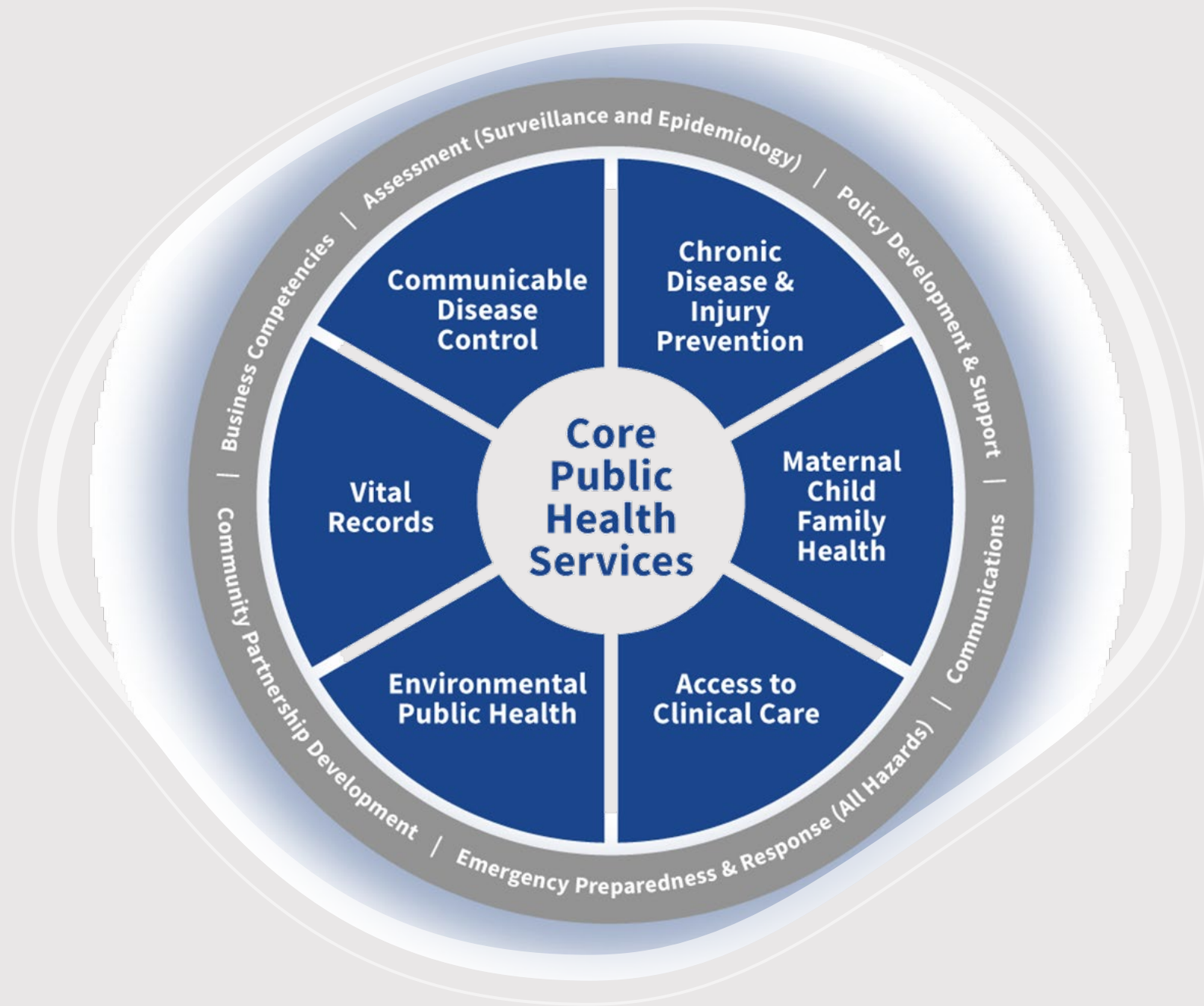

Heat and Wildfire Smoke

Our teams across Public Health and Emergency Management have been working closely with community partners to share prevention guidance and plan action steps, including implementing a heat check-in process for at-risk populations, implementing youth activity guidelines, sharing social media toolkits, and creating and developing print materials. Social media kits shared with community partners have generated significant reach for at-risk populations. Candida Auris

Candida auris (*C. auris*) is an emerging, often multidrug-resistant yeast, that spreads easily in high acuity facilities among patients with invasive devices. ***C. auris* is not a risk to the general public nor to most hospitalized patients.** *C. auris* was first detected in Washington in 2023. Since January 2024, Washington DOH has seen an increase in [C. auris cases](#).

Dengue Fever

The Centers for Disease Control and Prevention (CDC) issued a Health Alert Network (HAN) Health Advisory to notify healthcare providers, public health authorities and the public of an increased risk of dengue virus (DENV) infections in the United States in 2024. Global incidence of dengue in 2024 has been the highest on record for this calendar year; many countries are reporting higher-than-usual dengue case numbers.

In 2024, countries in the Americas have reported a record-breaking number of dengue cases, exceeding the highest number ever recorded in a single year. From January 1 – June 24, 2024, countries in the Americas reported more than 9.7 million dengue cases, twice as many as in all of 2023 (4.6 million cases).

In the United States, Puerto Rico has declared a public health emergency (1,498 cases) and a higher-than-expected number of dengue cases have been identified among U.S. travelers (745 cases) from January 1 – June 24, 2024.

In the setting of increased global and domestic incidence of dengue, healthcare providers should take steps including:

1. Have increased suspicion of dengue among people with fever who have been in areas with frequent or continuous dengue transmission within 14 days before illness onset.
2. Order appropriate diagnostic tests.
3. Ensure timely reporting of dengue cases to public health authorities.
4. Promote mosquito bite prevention measures among people living in or visiting areas with frequent or continuous dengue transmission.



For many in Island County, heat is difficult to avoid. When heat becomes dangerous, here are some steps that you can take to keep yourself and others safe.

FIND ALTERNATE PLACES TO COOL DOWN

If you are unable to cool your home, it's important to find alternate places to cool down.

Our local Sno-Isle libraries can offer relief. You can also visit your local office of emergency management to find cooling center locations, or try entering your zip code at www.211.org to find a community cooling center near you.

If you are unable to get someplace cool, use cool clothes or even a t-shirt from the freezer to wear around your neck during extreme heat advisories or warnings.



HERE ARE SIMPLE WAYS TO COOL DOWN YOUR HOUSE

- Add curtains to windows.
- Limit-heat producing appliances during the day.
- Cross-ventilate rooms by opening windows at night.
- Check weather stripping on doors and windows.
- Install ceiling fans to help circulate air. Remember, fans create air flow, but do not reduce body temperature or prevent heat-related illnesses.

CHECK IN WITH NEIGHBORS, FRIENDS, AND FAMILY

Extreme heat can cause serious health problems, especially for older adults.

If you are alone and in high heat, let someone know and set regular check in times. If you are a caregiver to an older adult, make sure you have a plan for keeping them cool during a heatwave.

Even if you are not responsible for your neighbors, family and friends, it's a good idea to check in on them when you can. Not everyone has the same access to resources and information as you do. Your check-in can save a life.

HEAT RASH	<ul style="list-style-type: none">• Red clusters of small blisters that look like pimples on the skin (usually on the neck, chest, groin, or in elbow creases)	<ul style="list-style-type: none">• Stay in a cool, dry place• Keep the rash dry• Use powder (like baby powder) to soothe the rash
