Commissioner Price Johnson opened the public hearing to consider:

- Ordinance C-89-11 (R-28-11) Regulating Speed Limit on Glendale Road
- Ordinance C-90-11 (R-29-11) Regulating Speed Limit on Lancaster Road
- Ordinance C-91-11 (R-30-11) Regulating Parking on a Portion of Ferry Dock Road
- Ordinance C-92-11 (R-31-11) Regulating Speed Limit on East Harbor Road

Mr. Oakes provided a Power Point presentation that explained the proposed reductions in speed for roads Glendale, Lancaster, and East Harbor, and proposed parking restriction on Ferry Dock Road.

The floor was then opened to public comment, first on the issue of East Harbor Road. Those commenting included:

Two community members who started the petition requested the new speed limit be set even lower to 25 miles per hour. Mr. Oakes explained that the speed study supported 50 miles per hour; however, the Board requested the speed be reduced to 40 miles per hour.

There was no public comment on the proposed reductions in speed for Glendale Road and Lancaster Road, or on the issue of restricted parking on Ferry Dock Road.
