Island County has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS). The optional DNS process established by WAC 197-11-355 is being used. **The public comment period as described below may be the only opportunity to comment on the environmental impacts of the following proposal.**

**Proposal:** Utilize a 40.77 +/- acre parcel zoned Rural, as an Environmental Education Retreat Center with associated appurtenances such as, septic system(s) restrooms, toolsheds, kitchen with dining hall and caretaker residence. With new parking serve approximately 40 guests plus support staff with most programs/ activities would occur during the summer and shoulder seasons. No more than 40 retreats will occur each calendar year. Each retreat will be approximately four to fourteen days in duration and no event will exceed 75 individuals. The improvements would additionally add housing for staff and participants attending the educational retreat center events. There will be future grading/clearing necessary for the development, but the parcel contains wetland and streams, but the proposal shows development will not impact Critical Areas.
