

- 18% of our investment pool is currently liquid and 20% is < 1-year maturity (assuming no calls).
- As of December 31, the 2021 property tax levies for Current Expense, Roads, and Conservation Futures were 98% collected. The comparable YTD collection for December 2020 was also 98%.
- Comp tax of \$28,700 was collected in December; Island County's portion is approximately \$4,700.
- Foreclosure Update – 2021 started with 58 properties in foreclosure; the final count was 9. The online auction was December 7 and 8th, with a re-auction of one parcel on the 15th:

- The number of REET affidavits processed in December was 402 compared to 435 in November and 493 in December 2020. The County's portion of excise revenue was \$463,729 in December, on sales of \$117 MM. This REET activity resulted in Island County YTD excise revenue of \$1.6 MM more than for the same period in 2020, and \$2.5 MM more than in 2019.

Investment Earnings Rate Comparison, January 2019 - December 2021






