**Manual Recount of Island County Assessor  
General Election – November 8, 2022  
Report to the Canvassing Board at Certification of Recount Results**

1. Per authorization of the Canvassing Board, on Monday, December 5, 2022 at 9:00 a.m., the seals on the containers of voted ballots were removed and the ballots were sorted into individual precincts. The total number of ballots sorted in each precinct were verified against the number of ballots tabulated during the General Election.
2. All 43,368 ballots cast in the general election were accounted for and included in the manual recount.
3. The recount of the race was completed and the results verified by precinct.
4. All ballots were processed according to statute by Auditor staff.
5. Differences in the votes tabulated during the recount from the tabulation in the original election results were:
  - a. Ballots that had the write-in box marked were originally tabulated as write-in votes, that had nothing written on the corresponding line and should have been tabulated as undervotes.
  - b. Write-in votes that should have been tabulated for the official candidate, but were originally tabulated as a write-in votes.
  - c. Ballots where the voter did not fill in the box, but used a mark in the box that was not able to be read by the scanner (faint/light colored ink, extremely small "x", small checkmark, slash line)
  - d. A ballot where the voter crossed out their vote, but did not make another choice was tabulated as a vote for the candidate, but should have been tabulated as an undervote.
