

The LPHSA & CPA

Local Public Health Systems Assessment	NEW Community Partner Assessment for MAPP
<ul style="list-style-type: none">• What are the components, activities, competencies, and capacities of our public health system?• How well are the 10 Essential Public Health Services being provided in our system?	<ul style="list-style-type: none">• What capacities, skills and strengths does each organization involved in MAPP bring that could contribute to improving community health and advancing the MAPP goals?• Who is involved in the MAPP process? Who else needs to be involved?
<p>Note: MAPP 2.0 will include various other assessments and tools that will capture competencies, partnerships/ relationships, and capacities (eg., in the Starting Point Assessment, Stakeholder Analysis, etc.) that will feed into the CPA and/or use CPA findings to inform next steps.</p>	

What is the CPA?

- The Community Partners Assessment (CPA) is a new assessment tool developed for MAPP version 2.0 designed to replace the historical Local Public Health Systems Assessment (LPHSA).
- The CPA is an assessment process that allows all of the community partners involved in MAPP to critically look at
 - 1. their own individual systems, processes and capacities
 - 2. their collective capacity as a network/across all community partners to address health inequities.
- This tool will help identify the range of actions that are currently being taken and could be taken moving forward to address health inequity at the individual to systemic and structural levels.

Mixed Methods Approach

- Qualitative Methods
 - Partner Discussion Meeting
- Quantitative Methods
 - Developing and Administering Surveys (CPA Survey)





Administer the CPA Survey

Share the survey with each organization participating in the CPA (~2 weeks for responses, ~2 weeks follow up)

Survey covers approximately 60 questions covering

- About your organization
- Organizational capacities
- Specific capacities to support the MAPP collaboration
- Completion time 35-45 minutes

Provide technical support with completion as needed

Summarize survey findings

Facilitate Partner Discussions

Facilitate conversations with CPA partners about topics like:



Community Status Assessment

Primary Data Collection

Using Surveys

- Designed to gather quantitative data that can be summarized as a percent or number to understand an issue.
- Developed as a questionnaire with closed-ended questions and includes some open-ended questions to elicit more information from the participant.
- Pros: Convenient, inexpensive, and used to collect data from a large population. Conducted online, using Qualtrics



Secondary Data Collection

Extracting Publicly Available Secondary Data

Involves data mining or extracting publicly available data, we use mySidewalk along with additional national, state, and local informatics to gain a full picture of your community.

Community Status Assessment

Step 1: Identify Indicators to Inform the CSA

Step 2: Collect Data

Step 3: Organize, Analyze & Interpret Data

Step 4: Develop community survey instrument

Step 5: Disseminate survey

Step 6: Compile Result

Step 7: CSA draft



Community Context Assessment

The CCA is organized in 3 domains

Community Strengths and Assets

- Inventory the strengths and assets that community members themselves possess and how those strengths and assets can be used to improve community health.

Built Environment

- Asset mapping of the built environment, particularly within neighborhoods experiencing the greatest inequities.
- How community members view and interact with the built environment around them, and how that might impact their health.

Forces of Change

- Forces (trends, factors, or events) in the recent past, present, or future that can affect the community and local public health system



Guiding Questions

- What strengths and assets do members of your community possess?
- How do these community strengths and assets contribute to community health?
- Which strengths and assets can be leveraged and strengthened to address health inequities?

The local health department and Ascendant Healthcare Partners working together to answer these questions to build their inventory.

Domain 2: Built Environment

Guiding Questions

- What physical assets and resources exist in the built environment of your community?
- How do these resources differ across neighborhoods, particularly in neighborhoods experiencing the greatest health inequities?
- How do community members view and interact with their local built environment?
- How do these interactions impact the health of community members?
- What are key aspects of the built environment in our communities that impact health inequities?
- How can those be improved or addressed to improve community health?

Questions are added to the Community Context Assessment (community-wide) survey to include built environment and assets of the community.

Domain 3: Forces of Change

Guiding Questions

- What is occurring or might occur that affects the health of your community or your local public health system? (These can be both things within your community and things in the larger societal and economic context of your community.)
- Which communities are disproportionately impacted by these forces of change? How and why are they disproportionately impacted?
- How does historical and structural context (e.g., of broken treaties, exclusionary policies, dehumanizing practices, or history of resistance and community organizing) shape the forces of change at play today, and who benefits from current conditions?
- How have climate change and COVID-19 changed conditions in your community?
- What have health departments done to help?

At the beginning of the Forces of Change meeting a summary of the CPA and CCA is presented to inform partners and the community on current findings.
