Proposal – Shoreline variance for after-the-fact replacement of an upper story deck with a roof and replacement deck.

Island County has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS). The optional DNS process established by WAC 197-11-355 is being used. The determination is based on the following findings and conclusions:

- The applicant will adhere to best management practices and the submitted SEPA Checklist.
- No change in shoreline stabilization measures will occur as a result of this project.
- The proposed replacement roof will be located in the same area as the previous impervious upper story deck. No additional impervious surface will be added to the site.
- There were no new impacts within critical habitat.

The following conditions have been identified that may be used to mitigate the adverse environmental impacts of the proposal:

- If Shoreline development is proposed where the marine shoreline buffer does not have “native vegetation throughout,” buffer enhancement is required
- Removal of un-permitted sections of roof overhang shall be required. The applicant also will remove portions of un-permitted impervious pavers to decrease the impervious surface ratio.
