Proposal – Clear approximately 35,000 board feet worth of timber leaving approximately 25 trees per acre to clear for new SFR with appurtenances. Total cleared area approx. 1.86 acres of 7.23 acre parcel. Project is in the vicinity of Wetlands, Steep Slopes, Unstable Slopes, Flood Zone, Feeder Bluff, and Cultural Resources.

Island County has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS). The optional DNS process established by WAC 197-11-355 is being used. The determination is based on the following findings and conclusions: Clearing is confined to the flattest portion of the parcel sufficient distance from the steep/unstable slopes and no cut greater than 1 ft is expected. Majority of the area will remain forested.

Island County regulations under ICC 17.02B (Critical Areas), Title XI (Land Development Standards) & other applicable regulations are used to review and condition development to protect critical areas affected by this proposal. The proposal may include mitigation & the project review process may incorporate or require mitigation measures regardless of whether an EIS is required.

Proposal – To extend culvert along front of lot, construct new SFR with appurtenances including installation of new septic tank. Project is in the vicinity of feeder bluffs, critical drainage, FWHCA, Cultural Resources, and flood zone.

Island County has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS). The optional DNS process established by WAC 197-11-355 is being used. The determination is based on the following findings and conclusions: The project is not projected to reduce sediment supply and will have no measurable impact on the flood storage area or volume of Puget Sound. No disturbance will occur below the OHWM and will thus not impact ground fish habitat. No change in function of the coastal pelagic EFH resulting from this project is expected.

Island County regulations under ICC 17.02B (Critical Areas), Title XI (Land Development Standards) & other applicable regulations are used to review and condition development to protect critical areas affected by this proposal. The proposal may include mitigation & the project review process may incorporate or require mitigation measures regardless of whether an EIS is required.

All work will be done from positions above the OHWM. All work shall be completed with clean equipment in good condition with no detectable petroleum product leakage.
