### Introductions & Updates

- Presentation by Colin Hume on Climate Resilient Riparian Funding Grant opportunity- Climate Resilient Riparian System Lead (CR2SL) are announcing a new grant program. Colin shared more about this riparian specific funding source, and we discuss potential projects and if they would be possible or competitive. Their goal is to fill the gaps –not do more of the same, making sure that these funds are addressing the barriers that partners are facing on the ground.
- \$25M Federal (EPA) funding arrived with a 7 year Agreement in Coalition with State Conservation Commission and Bonneville Environmental Foundation to Support restoration and protection of riparian areas in Puget Sound Innovative approaches to accelerate recovery. They are looking for programmatic proposals, Strategy of program matches Focus Area/Reach scale with Salmon Recovery and Water Quality Priorities. Land Use and Landowner demographics with proposals across multiple Investment Priority categories to create a holistic program that can be sustained. Aim to provide flexibility in grant management to address emerging opportunities. Potential for streamlined funding in the future. Restoration Implementation to focus on improving and restoring functional riparian systems along rivers and streams both at new sites and at existing. Plan for reach-scale priority restoration sites. This plan includes costs associated: Project planning and project management ,Plant procurement, site preparation, natural bank stabilization , Planting, plant establishment, and site maintenance for the initial 1-5 years after planting occurs. Minimum awards of \$500,000, Maximum awards of \$2,750,000, No match

- Riparian restoration and protection focused funding opportunity is open from the Climate Resilient Riparian Systems Lead to support the following community identified priorities in Puget Sound watersheds:
  - Priority A: Collaborative, reach-scale planning and outreach
  - Priority B: Native plant materials
  - Priority C: Landowner incentives
  - Priority D: Riparian restoration implementation
  - Priority E: Maintenance, monitoring, and adaptive management
  - Priority F: Permanent protection of riparian habitatThe 2024 fall solicitation will encourage applicants to propose collaborative and programmatic projects that include activities from one and up to all of the priorities. More funding opportunities are anticipated with potential funding for smaller program needs that will catalyze work in focus areas and for innovative research and approaches to address specific challenges. Applicants are encouraged to apply in early rounds.  
During this funding cycle, the grant program will invest approximately \$9 million into proposals that support collaborative and programmatic approaches which include activities from one and up to all of the priorities listed above. - ILIO- Reviewed what Island Local Integrating Organization is and how our committees work together and differences in committee structure. Thanks to ILIO members for attending this meeting and anticipating that we will have another shared meeting in December. Next month we will hear more on the new PIC funding and LIO one time OSS funding received to be used with the Shore Friendly Program, from DNR manager. The mission of the Island LIO is to achieve ecosystem recovery and improve resilience for the Island watershed through collaboration between multiple stakeholders. The ILIO weaves together strengths of existing watershed groups, tribes, and government agencies to facilitate and integrate environmental project development, planning and implementation. The ILIO structure does not duplicate efforts of the existing watershed groups, but rather coordinates these groups for planning and priority setting, project development and implementation. The ILIO is comprised of an Executive Committee (EC) made up of elected officials from the watershed as well as tribal representatives, and a Technical Committee (TC) staffed by the DNR manager.
- [Island County's 2025 Comprehensive Plan Update](#) Shared that workshops and survey for the future of Parks is happening. Community Invited to Help with Element 7 Parks & Recreation of the 2025 Island County Comprehensive Plan. The plan will provide directions and goals for the management of parks, recreation facilities, habitat areas, and natural resource areas in Island County. This project is critical because it provides an opportunity to address declining funding resources, which have made it difficult for the County to provide and care for parks and natural resources on Whidbey and Camano Islands. To make the Plan successful, County Parks would like to hear from as many people as possible. Residents are encouraged to participate in one of several public involvement events. Community feedback is needed to determine how the County can manage its existing resources, while working with other key partners to protect important natural resources and habitat areas countywide.

- Whidbey Basin update- HSIL grant awarded <https://pugetsoundestuary.wa.gov/2024/07/09/sil-2024-investment-plan/> See [Investment List](#) for details of Whidbey Basin project- Building Reliable Habitat Restoration Information in the Whidbey Basin Lead entities (LEs), as the watershed-based groups tasked with working with project sponsors to implement salmon recovery projects, are uniquely positioned to document and share the story of restoration throughout a watershed. We reviewed some of the other projects in our area on this list. LE shared other projects receiving HSIL funding associated with WRIA 6 area. This included awards to the Fisheries Enhancement Groups that work in WRIA 6 - Skagit Fisheries Enhancement Group and Sound Salmon Solutions.
- Whidbey Basin- LE coordinator has been attending monthly meetings the other Whidbey Basin LEs and sharing grant round details and funding distribution information.

- The Salmon Recovery Funding Board (SRFB) Request for proposals (RFP)for 2025 WRIA 6 grant round will be advertised and available on December 13<sup>th</sup>. This is expected to be a small funding year around two hundred and seventeen thousand in SRFB allocation. - In 2024 we saw 5 projects in Island County receive Salmon Funding: Livingston Bay protection, Cultus Bay evaluation, Race Rd. culvert replacement and Double Bluff protection, not forgetting the Skagit LE contributed allocations to the Race Lagoon project and Enhancement of Maylor Marsh. Double Bluff project looks to have funding allocated through the Target Investment route, as the Climate Commitment Act was not repealed. - The Habitat, Shellfish, and Stormwater Strategic Initiative Leads (SILs) [recording](#) and [pdf](#) of the October 30, 2024 All Boards Webinar: Celebrating SIL 1.0 Cooperative Agreements and Looking Ahead in Puget Sound Recovery. The SILs also have a [1-pager available](#) highlighting SIL and SIL-funded partner accomplishments.
- Keystone Cost overrun with confirmation and review of decision in 2023 to allocate what leftover funds we had available and that we did not fund the full ask. There are more funds required and they will look to ESRP and PSAR return funds, as we have no roll over and return at this time. - Status of SRTCC committee with need to replace COG member. Need to find a replacement for Commissioner St Clair before March and BOCC is aware of need.
- [Skagit Fisheries Enhancement Group](#) (SFEG) with Yuki giving us an update on the plan for the mini grant of \$10,000 to conduct outreach with willing landowners and a community restoration planting plan with native plants. She had met with LE, Watershed planner and Conservation District to work out a plan and see what approvals were needed. Since only one culvert is now to be replaced after 2024 grant round due to RCO conditions, the scope of mini grant has had to change. They propose to pivot as landowners are interested in restoration and the next important step would be to convert some of the open field areas to active wetland. They are looking in to permit requirements and cultural resources. PW and WCCD offer to help with this. ICPW Race 2024 project update that they are working with RCO on requests.
- [Whidbey Conservation District](#)- A project near Race Rd. culvert has been involved with the "[wet feet farming](#)" through the conservation district. James to give us a general overview on this program next month as many farms involved look to be from Whidbey.
- [Sound Salmon Solutions](#) shared recent attendance at Youth Summit. The event was created out of a workforce development group that includes the Northwest Indian Fisheries Commission, the National Oceanic and Atmospheric Administration, tribal education professionals, and environmental organizations. The group supports information exchange between tribes and organizations that support tribal education in natural resources. SSS recently hired a restoration manager and Brittany shared on this, [Native Youth Salmon Summit](#).

- Reports of good salmon runs of Coho and Chum in our area. Coho being caught off the shoreline near Keystone. Chum reported swimming upstream at Kristorferson creek. Talk of Beaver Dam and how high it is and how water coming from the beaver marsh and golf course flowing through Can ku culvert and if flow will change stream route at the beaver dam.
- Seven active projects 7 Active Projects: Keystone, Crescent middle and riparian lower, Race culvert replacement, Livingston Bay, Can Ku Culvert, and Hoypus. History of WRIA 6 rank and look to Salmon Recovery Portal to see information on projects. New feature available to sort by and LE showed example from funding that went to Conservation Futures. <https://srp.rco.wa.gov/site/200>
- Southern Resident Orca whales [return to Penn Cove](#). Southern Resident killer whales have been hanging out in Puget Sound much longer than normal this fall, probably because of an unusually large run of chum salmon coming into Central and South Puget Sound, experts say. L pod made a surprising visit to the infamous orca-capture grounds in Penn Cove for what may be the first time in more than 50 years.
