Twenty-four additional COVID-19 cases have been reported in Island County between 10.14.20 and 10.21.20. Most recent cases in Island County are recovering at home and do not require hospitalization. Island County Public Health typically follows cases and close contacts of cases for 14 days, at which point they are considered no longer contagious (if they are symptom free). At this time, a clear definition of the term "recovered" has not been provided by the WA State Dept. of Health.

Following case investigation, no specific event or location was identified as having significant correlation to recent cases. Social gatherings and spread within family units appear to be associated with many of the new cases within Island County. New cases are also likely to be the result of relaxed adherence to county and [state COVID-19 guidance](#), including social distancing, non-essential travel, and masking recommendations.

Celebrate Safely

The more people we interact with at a gathering and the longer that interaction lasts, the higher the risk of becoming infected. Keep the [following tips](#) in mind as you celebrate this holiday season.



- ◇ Commit to fewer, shorter, and smaller gatherings
- ◇ Wash hands immediately upon arrival and frequently throughout the event
- ◇ Avoid indoor social gatherings (outdoor is better)
- ◇ Wear a face covering at all times
- ◇ Avoid communal food and sharing utensils
- ◇ Avoid close contact

Updated Guidance
