WHEREAS, Island County has adopted ICC 16.26 to guide the process for annual updates to the Island County Comprehensive Plan and associated plans pursuant to RCW 36.70A.130(2); and

WHEREAS, the County also recognizes that early and continuous public involvement is necessary to ensure updates are suitable for Island County; and

WHEREAS, Planning and Community Development compiled a list of proposed amendments for consideration for the annual review docket, including items that have continued from the prior year; and

WHEREAS, the Planning Commission considered the proposed items for placement on the 2022 annual review docket during work session at their regularly scheduled meeting on February 14, 2022; and

WHEREAS, the Planning Commission held a public hearing on February 14, 2022, and after public hearing recommended that the item on the 2022 annual review docket include:

- **Shoreline Master Program (SMP) Periodic Review and Update;** and
- **Ault Field Road - Commercial Rezone;** and

WHEREAS, at work sessions on September 1st, 2021, and December 15th, 2021, the Board of Island County Commissioners reviewed the proposed items for the 2022 annual review docket; and

WHEREAS, the Board of Island County Commissioners held a public meeting on March 8th, 2022, to consider approval of the 2022 annual review docket; and

WHEREAS, placing amendment proposals on the docket does not guarantee or imply ultimate approval;

NOW, THEREFORE, BE IT RESOLVED that the 2022 annual review docket, attached as Exhibit A, is hereby approved and adopted.
