**A RESOLUTION ESTABLISHING THE
ISLAND COUNTY 2019 ANNUAL
REVIEW DOCKET FOR
COMPREHENSIVE PLAN
AMENDMENTS**

WHEREAS, Island County has adopted ICC 16.26 to guide the process for annual updates to the Island County Comprehensive Plan and associated plans pursuant to RCW 36.70A.130(2); and

WHEREAS, the County also recognizes that early and continuous public involvement is necessary to ensure updates are suitable for Island County; and

WHEREAS, Island County notified the public that applications for amendments to the Comprehensive Plan are due before August 1, 2018; and

WHEREAS, Planning and Community Development compiled a list of proposed amendments for consideration for the annual review docket, including items that have continued from the prior year; and

WHEREAS, the Planning Commission considered the proposed items for placement on the 2019 annual review docket during work sessions at their regularly scheduled meetings on August 13th, September 10th, and September 24th; and

WHEREAS, the Planning Commission recommended that the items on the 2018 annual review docket that have not been completed be rolled over to the 2019 annual review docket or work plan, as appropriate:

- Adopting Freeland Development Regulations & related Subarea Plan updates will be rolled over to the 2019 Docket; and
- The remaining Rural Lands related code updates will not require Plan Amendment and therefore be moved to the 2019 Work Plan; and

WHEREAS, the Public Works Department has requested minor updates to processes outlined in chapter 10B, Capital Improvements Program; and

WHEREAS, Island County determined to create an Economic Development Element for the Comprehensive Plan during the 2016 Period Review, to be completed on an annual review docket cycle prior to the next periodic review; and

WHEREAS, at work sessions on August 1st, September 5th, and October 3rd, the Board of Island County Commissioners reviewed the proposed items for the 2019 annual review docket and the recommendations of the Planning Commission; and

WHEREAS, the Board of Island County Commissioners held a public meeting on November 20, 2018, to consider approval of the 2019 annual review docket; and

WHEREAS, placing amendment proposals on the docket does not guarantee or imply ultimate approval.


NOW, THEREFORE, BE IT RESOLVED that the 2019 annual review docket, attached as Exhibit A, is hereby approved and adopted.


