COURT OPERATIONS

This matter comes before the Court on the COVID-19 public health emergency in Washington State and Island County. The actions set forth herein will take effect on May 1, 2020, and will remain in effect until further order of the Court, unless otherwise stated herein. If a date is stated herein, the date may be extended by further order of the Court.

The Court reiterates its findings entered in its original Emergency Order entered March 17, 2020, to take effect March 19, 2020, its First Amended Emergency Order entered March 19, 2020, to take effect March 19, 2020, and its Second Amended Emergency Order entered March 20, 2020. In addition, the Court finds that the Supreme Court of the State of Washington entered its Second Revised and Extended Order Regarding Court Operations No. 25700-B-618 on April 29, 2020, a copy of which is attached hereto and incorporated by this reference herein. The Court adopts the findings of the Supreme Court as set forth in the WHEREAS clauses of the Supreme Court's Order. In the Order, the Supreme Court stated, among other things:

1. All civil jury trials remain suspended until at least July 6, 2020. ... Nonjury trials may be conducted by remote means or in person with strict observance of social distancing and other public health measures.

6. All criminal jury trials remain suspended until at least July 6, 2020. ... Nonjury trials may be conducted by remote means or in person with strict observance of social distancing and other public health measures.


As provided in this Court's First Amended Emergency Order No. 20-2-00002-15, all civil and criminal proceedings in Island County Superior Court shall be conducted by telephone or

video in accordance with the procedures outlined in this Court's original Emergency Order entered March 17, 2020.


NOW, THEREFORE,

IT IS HEREBY ORDERED that this Court shall enforce the Supreme Court's Second Revised and Extended Order Regarding Court Operations No. 25700-B-618. All civil and criminal jury trials are suspended until at least July 6, 2020. Pending the further order of this Court, and as provided in this Court's previous First and Second Emergency Orders, all civil and criminal matters, including non-jury trials, to be conducted in Island County Superior Court shall be conducted by telephone or video in accordance with the procedures outlined in this Court's Emergency Order entered March 17, 2020.
