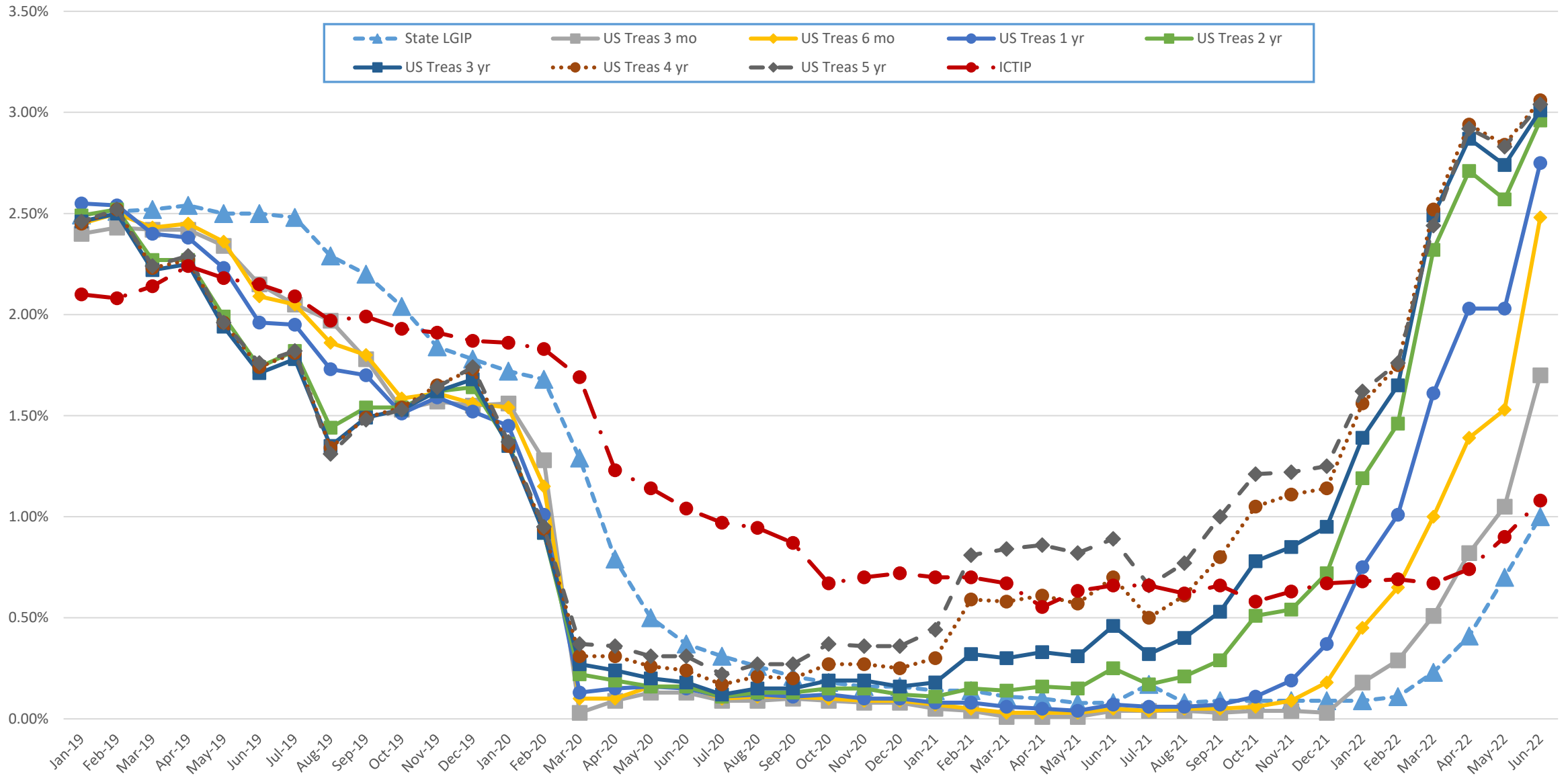

- 19% of our investment pool is currently liquid and 23% is < 1-year maturity (assuming no calls). Liquidity of total funds including bank balances is 23%, which satisfies our Investment Policy requirement of 20% minimum liquidity.
- Property tax statements were mailed February 22. As of June 30, the 2022 property tax levies for Current Expense, Roads, and Conservation Futures were 55% collected. 2021 YTD collections for June were 56%.
- Foreclosure Update – 2022 started with 58 properties subject to foreclosure, and 22 mobile homes subject to distraint. As of June 30, the count is down to 12 and 5, respectively. We have a 17-parcel tax title property sale scheduled for July 25; GovDelivery bulletins were just sent this week to those subscribers signed up for Foreclosure Sale information.
- The number of REET affidavits processed in June was 383 compared to 355 in May and 490 in June 2021. The County's portion of excise revenue was \$586,755 in June, on sales of \$160 MM. This REET activity resulted in Island County YTD excise revenue of \$190,860 less than for the same period in 2021, and \$1,179,256 more than in 2020.

Investment Earnings Rate Comparison, January 2019 - June 2022

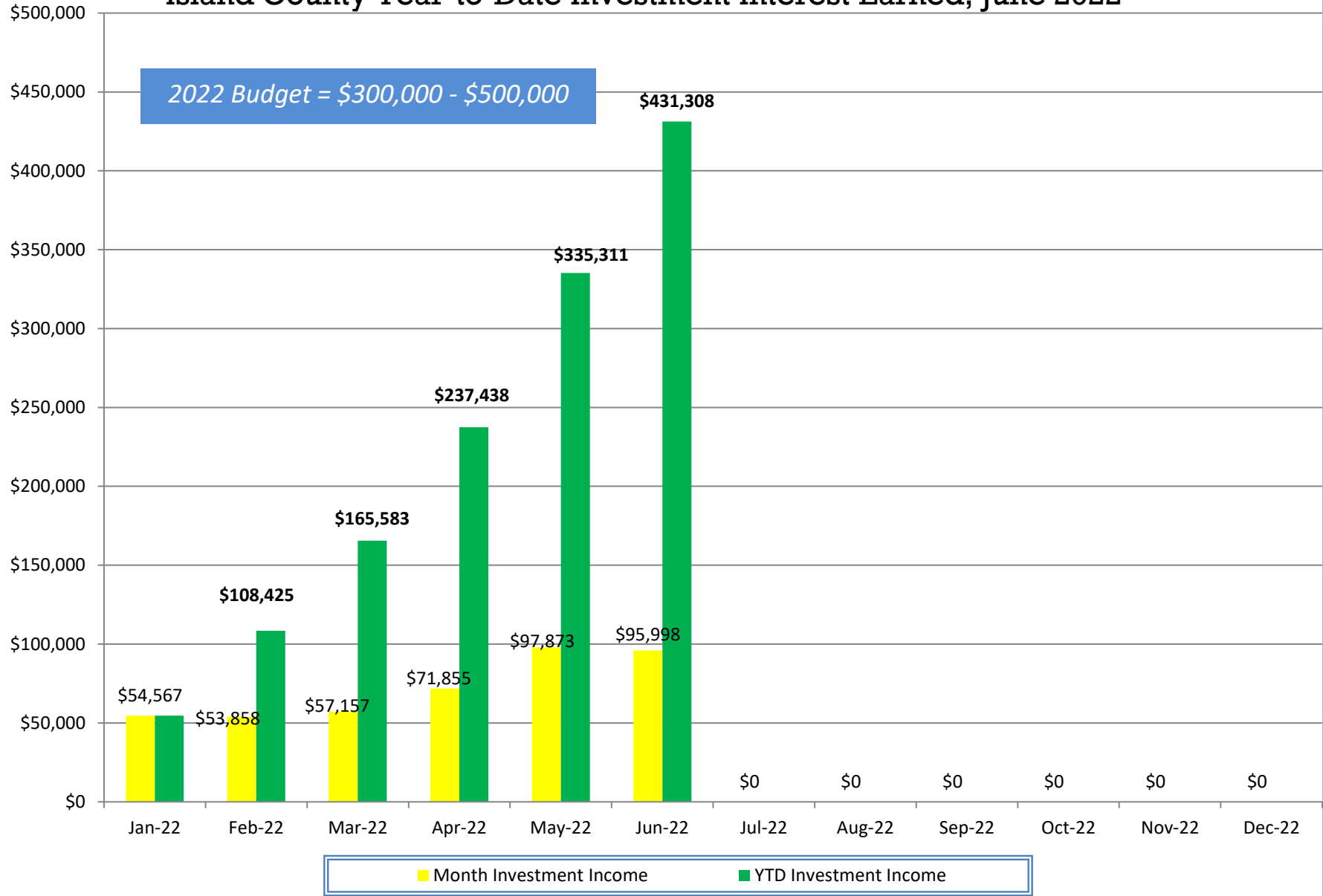

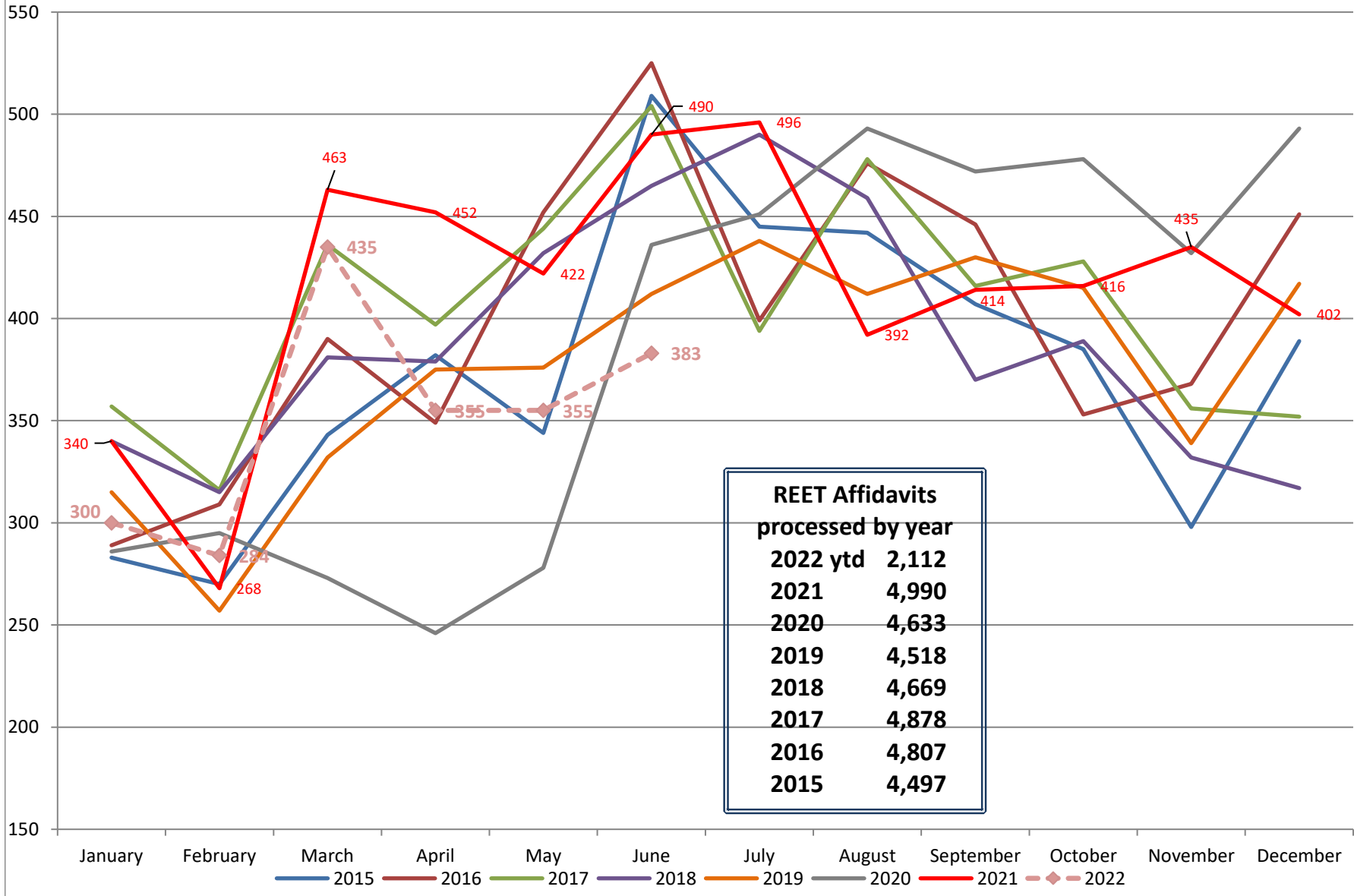

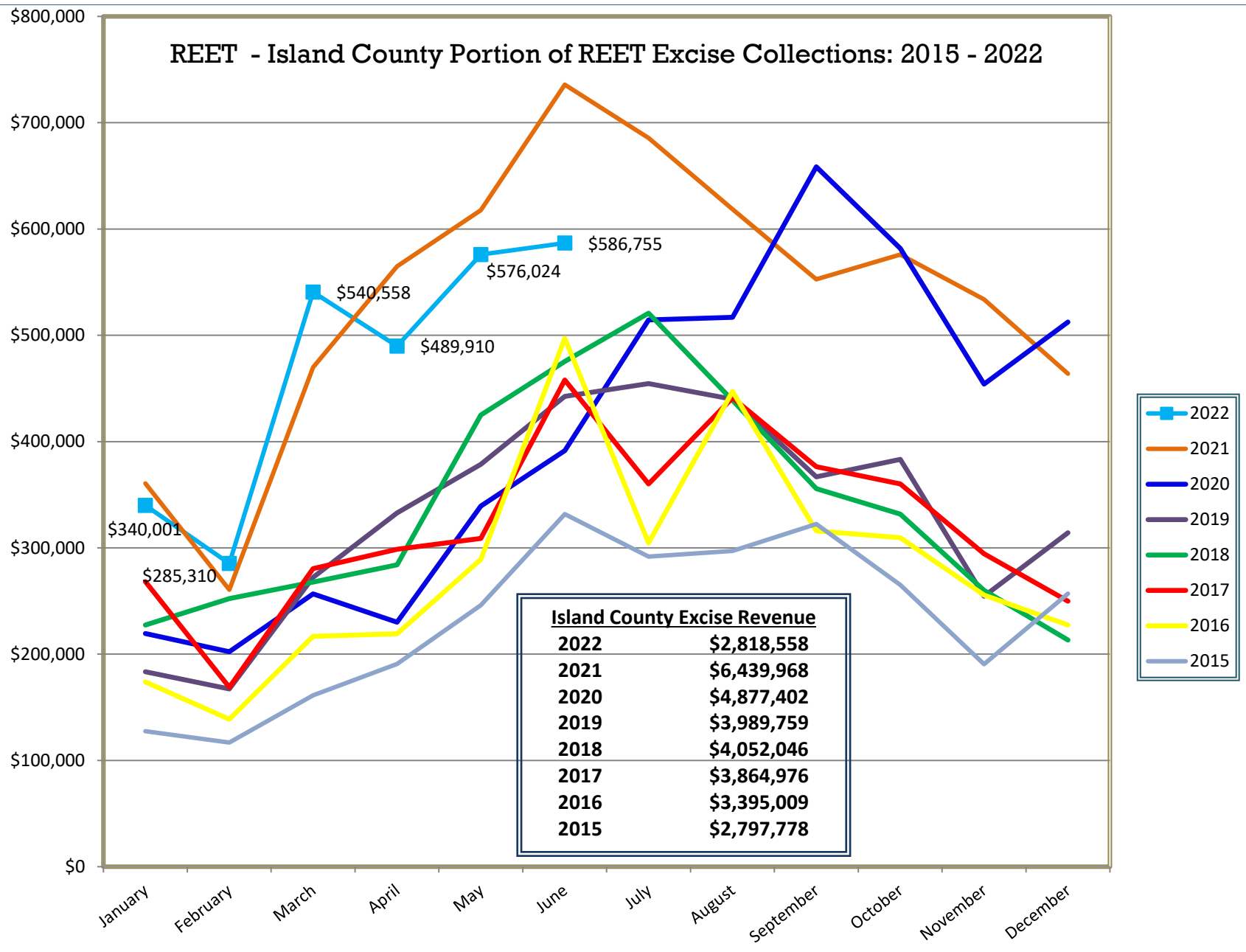


Island County 2015-22 REET - Number of Affidavits Processed by Month



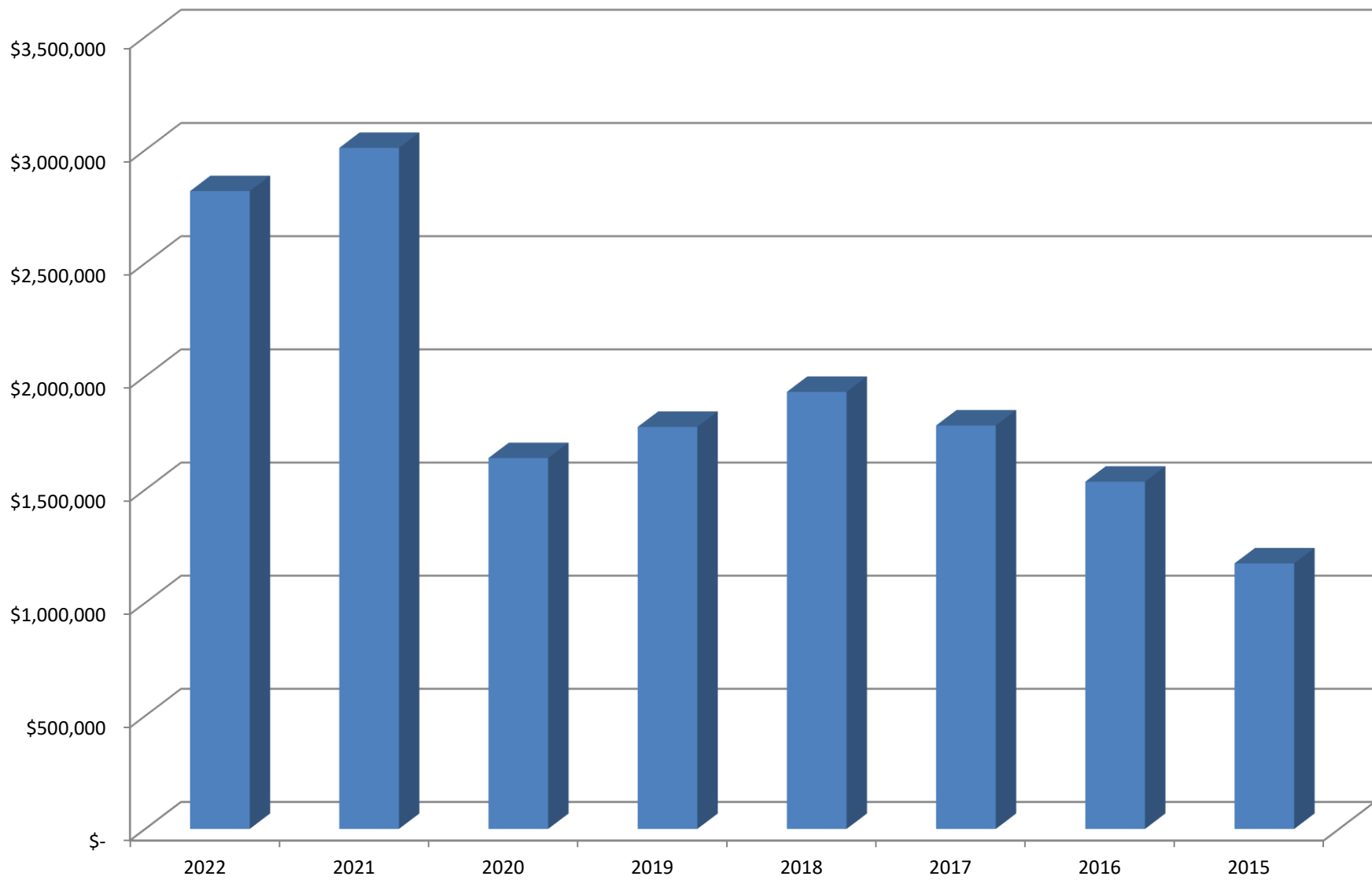
